The concept of privacy in 1984 does not exist at all due to constant surveillance and control; however, in real life we may have privacy, but our information is available for


others and we are constantly exposed without our consent.

All our personal information is available for various organizations, for example, the government/Ingsoc, banks, schools, airports, websites...




Other similarities:
